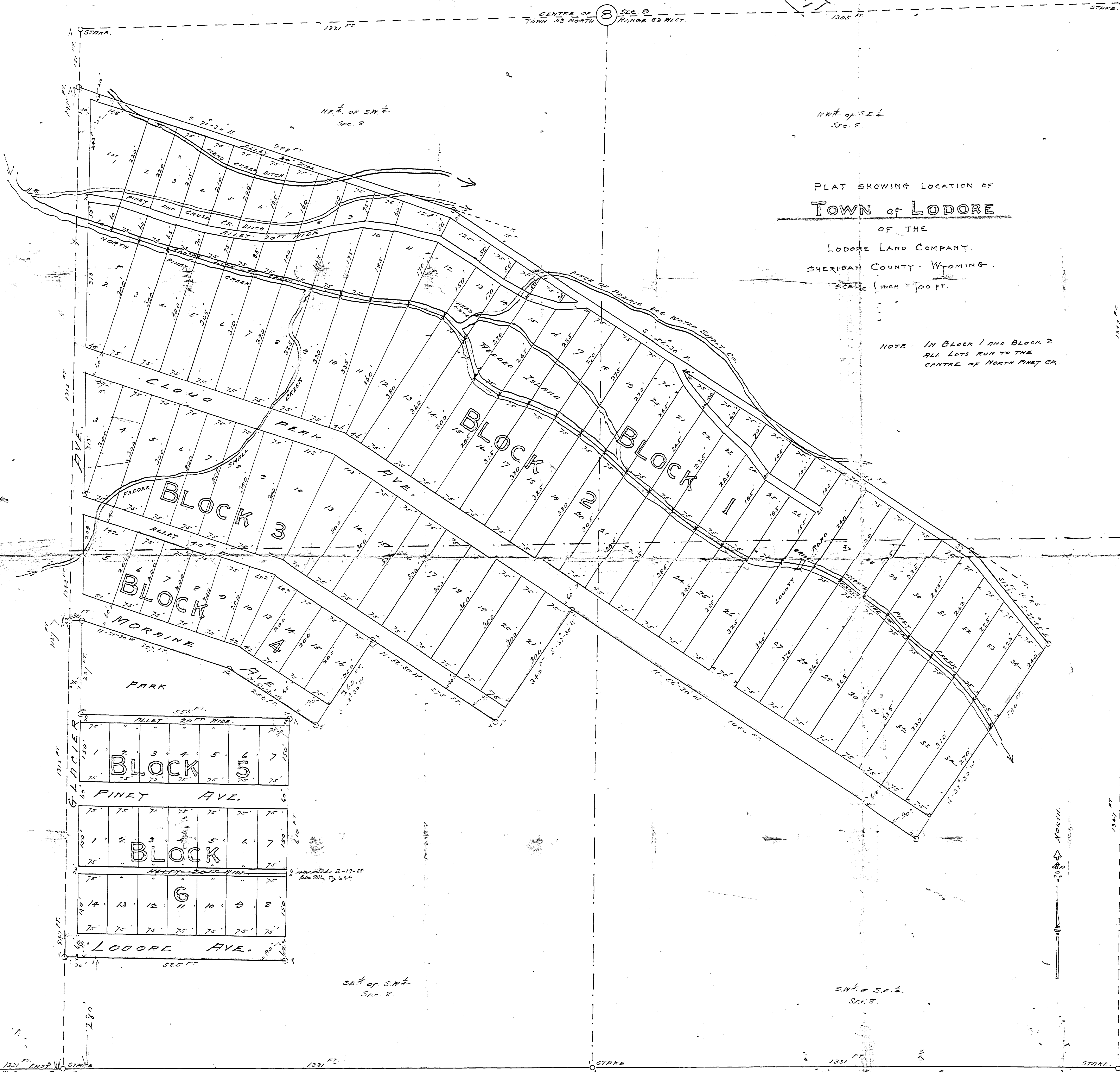




PLAT SHOWING LOCATION OF

I, the Lodore Land Company, a corporation organized and existing under the laws of the State of Wyoming, do hereby certify that the following description of land is true and correct: Corner and perspective of the following described piece of land to wit: Section 8, Town 53 North, Range 83 West, on the East line of the South East quarter of the South West quarter of said Section 8; Thence South 71° 30' East 988 feet; Thence South 56° 30' East 1553 feet; Thence South 39° 45' East 313 feet; Thence South 33° 30' East 590 feet; Thence North 56° 30' East 1050 feet; Thence South 33° 30' East 340 feet; Thence North 56° 30' East 375 feet; Thence South 33° 30' East 260 feet; Thence North 56° 30' East 259 feet; Thence North 71° 30' East 397 feet; Thence West 30 feet, to the West line of the South East quarter of the South West quarter of said Section 8; Thence North 1348 feet to bearing point, located in the N 8° of the 5th, the S 8° of the 5th, the N 8° of the 8th and the S 8° of the 5th of said Section 8; Thence North 1127 feet to the South West corner of the South East quarter of the South West quarter of Section 8, Town 53 North, Range 83 West, on the West line of said Section 8; Thence East 555 feet; Thence South 610 feet; Thence West 585 feet, to the West line of said Section 8; Thence North 847 feet to bearing point, located in the S 8° of the 5th of Section 8; Thence North 847 feet to bearing point, located in the S 8° of the 5th of Section 8.
