**DEFAULT JUDGMENT**

THIS MATTER came before the Court on Plaintiff's Motion for Default Judgment against Defendant R and R Paint and Restoration, LLC and Defendant Victor Rodriguez; the Court has reviewed the pleadings and is otherwise fully advised in the premises and finds as follows:

1. Plaintiff filed its Complaint on November 9, 2021.
2. Defendant R and R Paint and Restoration, LLC and Defendant Victor Rodriguez were served on November 12, 2021.
3. More than twenty (20) days have elapsed since the date of service, and Defendant R and R Paint and Restoration, LLC and Defendant Victor Rodriguez, have failed to plead as required by law.

4. The Clerk of this Court entered default against Defendant R and R Paint and Restoration, LLC and against Defendant Victor Rodriguez on Plaintiff's Complaint on December 3, 2021.

5. This Court has personal jurisdiction over all the parties named in the caption above and has subject matter jurisdiction over all the items referred to and set forth below.

6. There is no reason for delaying entry of judgment.

7. Plaintiff should recover the judgment against Defendant R and R Paint and Restoration, LLC and Defendant Victor Rodriguez, jointly and severally, for the liquidated sum demanded in the Complaint.

NOW, THEREFORE, IT IS HEREBY ORDERED, CONSIDERED, ADJUDGED AND DECREED AS FOLLOWS:

Pursuant to W.R.C.P 55(b), Plaintiff has a judgment against Defendant R and R Paint and Restoration, LLC, a Wyoming limited liability company, and against Defendant Victor Rodriguez, jointly and severally, for the sum of \$45,235.25, plus interest at the statutory rate.
