RIGHT OF WAY DEED FOR TELEPHONE LINE RIGHT OF WAY

KNOW ALL MEN BY THESE PRESENTS, that I, Emma W. Sackett, a widow, of the County of Sheridan, State of Wyoming, in consideration of One and no/100 Dollars (\$1.00) to me in hand paid, and other good and valuable considerations, the receipt whereof is hereby duly acknowledged, to hereby grant, bargain, sell and convey unto the United States of

America, and easement and right of way in gross over the following tract or parcel of land, situate, lying and being in the County of Sheridan, State of Wyoming, and bounded and particularly described as follows:

Section Twenty-four (24), Township Fifty-four (54) North, Range
Eighty-five (85) West of the Sixth (6th) Principal Meridian.

The said right of way hereby granted is for the construction, maintenance, and full free and quiet use and enjoyment of one line of poles bearing telephone wires and traversing the above, ^{described} premises according to the following general courses and directions, to-wit:

Beginning at Station 8, a point on the line between Sections 13 and 24,
T. 54 N., R. 85 W., of the sixth 6th Principal Meridian, from whence the
corner to Sections 13, 14, 23 and 24, bears S 89° 35' W, 726 feet distant,
and extending thence

S 13° 35' W.	1193 feet to Station 9
S 29°	W. 138 feet to Station 10
