## DECREE OF DISTRIBUTION OF PROPERTY BY SUMMARY PROCEEDINGS

THIS MATTER came before the Court upon the *Petition for Summary Distribution of Property Pursuant to W.S. § 2-1-205* ("Petition"), filed herein by Wade Creech ("Mr. Creech") and Timmy D. Voiles ("Mr. Voiles") (collectively "Petitioners") for a summary distribution of real property belonging to Dianna L. Voiles, deceased. Having considered the Petition and now being duly and fully advised in the premises, the Court **FINDS** as follows:

- 1. Dianna L. Voiles ("Decedent") died on the 3<sup>rd</sup> day of July, 2021, in Sheridan County, Wyoming. She was a resident of Sheridan County at the time of her death.
- 2. The value of Decedent's entire estate located in Wyoming subject to administration, less liens and encumbrances, including the real property, mineral interests, and personal property, does not exceed two hundred thousand dollars (\$200,000).
  - 3. More than thirty (30) days have elapsed since the death of Decedent.
- 4. No application for appointment of a personal representative in her estate is pending or has been granted in any jurisdiction.
  - 5. All medical assistance claims have either been satisfied or do not exist.
- 6. Mr. Creech and Mr. Voiles are Decedent's sole devisees and entitled to payment or delivery of property owned by the Decedent at the time of her death by virtue of the provisions of her Last Will and Testament, dated June 11, 2021, and filed herein as part of the

probate record. Specifically, Decedent's Last Will and Testament leaves her mineral interests to Mr. Voiles and her residuary estate to Mr. Creech.

- 7. There are no other distributees of the Decedent having a right to succeed to the property of Decedent under probate proceedings in any jurisdiction.
- 8. A Notice of Petition for Summary Distribution of Property was duly published in *The Sheridan Press*, a newspaper of general circulation in Sheridan County, once a week for two weeks, on September 20 and September 27, 2021.
- 9. There have been no objections filed as to the transfer of Decedent's property and the time for filing objections expired on October 21, 2021.

## IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED:

1. That by reason of the foregoing, all right, title and interest in the following described real property in Sheridan County, Wyoming, formally belonging to the Decedent, Dianna L. Voiles, is hereby transferred, conveyed and distributed to Wade Creech, so that Wade Creech and Timmy D. Voiles shall now own the property as tenants in common:

#### SHERIDAN COUNTY

Lot 6, Block 14, Sheridan Land Company Addition to the Town, now City of Sheridan, Sheridan County, Wyoming.

Together with all improvements situate thereon and all appurtenances thereunto appertaining or belonging.

Subject to all exceptions, reservations, rights-of-way, easements, covenants, restrictions, and rights of record and subject to any state of facts which would be disclosed by an accurate survey or physical inspection of the premises and subject to building and zoning regulations and city, state, and county subdivision laws.

2. All right, title and interest in the following described mineral interests in Campbell County, Wyoming, formally belonging to the Decedent, Dianna L. Voiles, is hereby transferred, conveyed and distributed to Timmy D. Voiles:
