EASEMENT

PRADERE and JUDITH L. PRADERE, husband and wife, of the County of Sheridan, State of Wyoming, Grantors, have and by these presents do hereby grant and convey unto DARROLL F. MILLER and CAROLINE A. MILLER, husband and wife, whose address is 44 South Main Street, Sheridan, Wyoming, 82801, their heirs, executors, administrators and assigns, Grantees, an easement to extend a 12-inch discharge pipe from the embankment of Withrow Reservoir No. 1, twentyfive (25) feet from the North boundaries of Tracts 25 and 26 of the McNally Third Subdivision, Sheridan County, Wyoming, owned by Grantees, across the South boundary of and onto Tract 21, McNally Third Subdivision, Sheridan County, Wyoming, owned by Grantors.

IT IS EXPRESSLY UNDERSTOOD by Grantors that this Easement is given to the Grantees, and their successors in interest, expressly upon the condition that Grantees shall install appropriate culvert, riprap, or other necessary works at the end of said pipe on Grantors' property, necessary to dissipate the pressure of the water discharged therefrom to prevent increased and unreasonable erosion of the property of Grantors, such works to be sufficient for the maximum summer discharge.

IT IS UNDERSTOOD AND AGREED that Grantees shall be liable for and responsible to correct increased and unreasonable erosion as a result of said works for a distance of twelve (12) feet from the end of said works.
