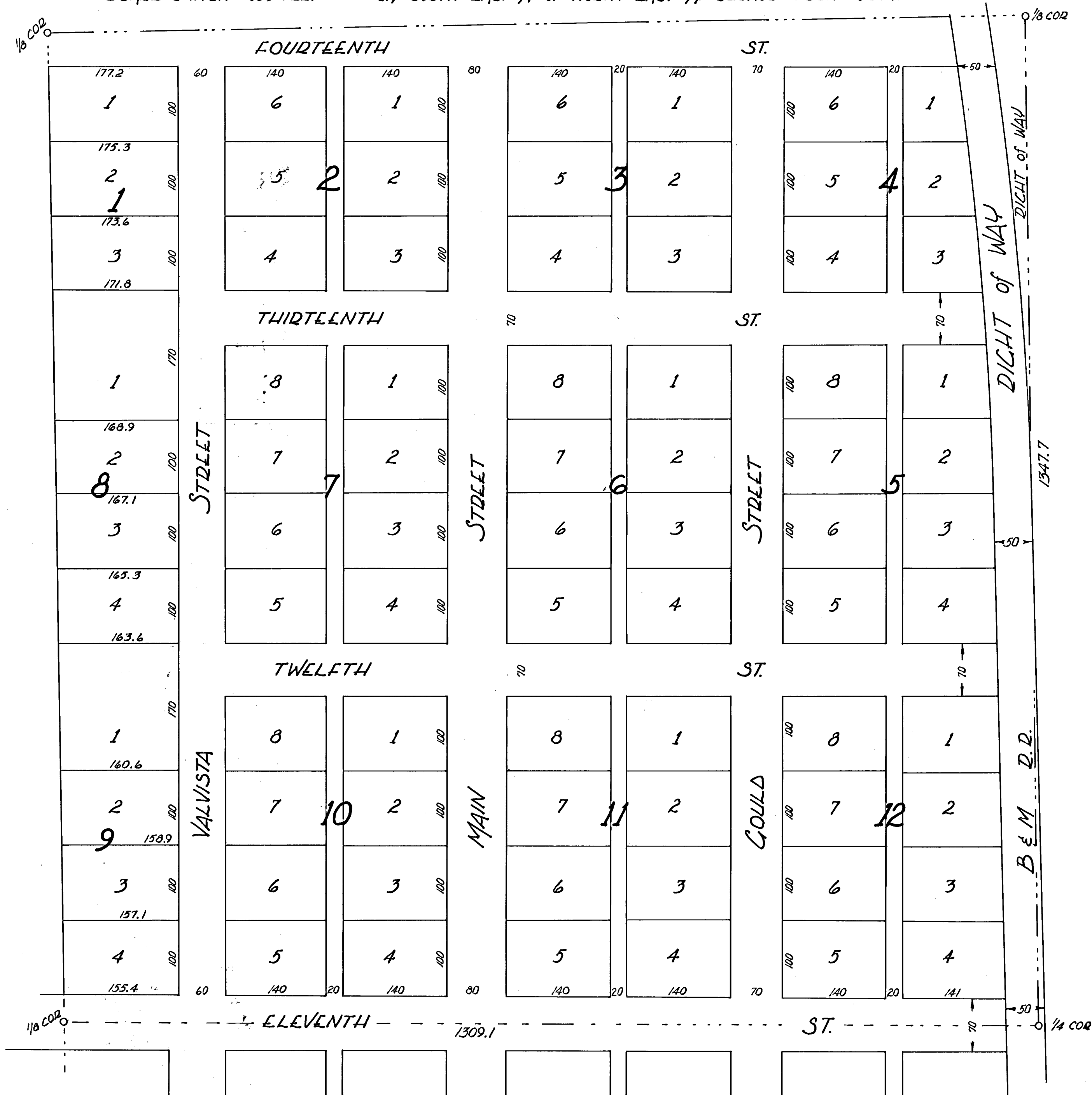


# ATKINSON'S ADDITION TO THE TOWN OF SHERIDAN, SHERIDAN COUNTY, WYOMING

I HEREBY CERTIFY THAT I AM A PRACTICAL SURVEYOR THAT IN THE MONTH OF MARCH 1893 I SURVEYED ATKINSON'S ADDITION TO THE TOWN OF SHERIDAN, SHERIDAN COUNTY, WYOMING, SAID ADDITION COMPRISING THE SOUTH EAST QUARTER OF THE NORTH EAST QUARTER OF SECTION TWENTY TWO (22) TOWNSHIP FIFTY SIX (56) NORTH, RANGE EIGHTY FOUR (84) WEST WITH THE EXCEPTION OF THE RAILROAD RIGHT OF WAY AS SHOWN BY THE ACCOMPANYING PLAT, WHICH IS A CORRECT DELINEATION OF SAID SURVEY DRAWN TO A SCALE OF ONE INCH TO ONE HUNDRED FEET.
