ORDER OF CONVEYANCE

The above entitled matter coming on regularly before this Court upon the Oral Motion of the Plaintiff for an Order of Conveyance of the below described property, and the Court being duly advised that an Order of Confirmation of Awards has been previously entered herein and that warrants of the Plaintiff, in the amounts set forth in said Order, payable to the Defendants, named therein, have been transmitted to the Clerk of Court, Fourth Judicial District, for payment of said awards to the respective owners of the below described properties.

IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED by the Court that the Plaintiff, City of Sheridan, Wyoming, a municipal corporation, is the owner and seized in fee simple of the following described lands lying in Sheridan County, to-wit:

PARCEL B

Oma E. Crosby, 3641 Linden Avenue, Seattle 3, Washington

That portion of Lot 5, Block 20, Sheridan Land Company's First Addition to the City of Sheridan lying North of a line described as follows:

Beginning at a point on the East line of said Lot 5, said point being 7 feet South of the Northeast corner of said Lot 5; thence West 30 feet to a point; thence South 10 feet to a point; thence West 42 feet to the West line of said Lot 5.

PARCEL C

Raymond L. Holmes, 607 Avea Street, Sheridan, Wyoming

That portion of Lot 6, Block 20, Sheridan Land Company's First Addition to the City of Sheridan lying North of a line described as follows:

That portion of West Second Street, created by Ordinance No. 484 of the City of Sheridan, lying West of a line described as follows:

Beginning at a point on the North line of Block 50, Sheridan Land Company's Addition to the City of Sheridan, 44.0 feet West of the West line of Val Vista Street; thence N. 7° 31' East 111.90 feet to the South line of Block 38, Sheridan Land Company's Addition, 39.5 feet West of the West line of Val Vista Street.

Also a tract of land 60 feet by 150 feet situated in the NE $\frac{1}{4}$ of Section 27, Township 56 North, Range 84 West, more particularly described as follows, to-wit:

Beginning at a point on the West line of Lot 1, Block 50, Sheridan Land Company's Addition to the Town, now City, of Sheridan, Wyoming, which point is 55 feet North of the Southwest corner of said Lot 1, thence West, parallel to the South line of said Lot 1 extended a distance of 60 feet to a point, thence North on a line parallel to the West line of said Lot 1 a distance of 150 feet to a point, thence East along the North line of Second Street of said City as extended, a distance of 60 feet to the Southwest corner of Lot 3 of Block 38 of said Addition, thence South a distance of 150 feet along the West line of said Lot 1, Block 50 of said Addition to the point of beginning.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that a copy of this Order shall be certified by the Clerk of Court and forthwith recorded by the Plaintiff in the Office of the County Clerk and ex-Officio Register of Deeds of Sheridan County, Wyoming, and that upon the recording and indexing of a certified copy of this Order, said Order shall constitute a Deed of Conveyance in fee simple of the above described tracts of land from the above named Defendants to the Plaintiff, City of Sheridan, Wyoming.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Plaintiff shall be discharged from any and all claims for and damages by reason of any matter specified in the Petition for Condemnation or any Order of the Court previously filed herein.

This Order is made pursuant to Section 1-777, Wyoming Statutes 1957.
