RIGHT_OF_WAY CONVEYANCE

FOR AND IN CONSIDERATION of the sum of One Dollar, and other valuable consideration, Will L. Davis and Sophia M. Davis, his wife, of Sheridan County, Wyoming, (hereinafter called the Grantors) do hereby grant and convey to Little Goose Utilities Corporation, a corporation, and to its

successors and assigns, (hereinafter called the Company) the right, privilege and easement, in perpetuity, to construct, operate and maintain an electric line for heat, power and light, including the necessary poles, wires and fixtures, upon, over and across the following described real estate in Sheridan County, Wyoming, to-wit:

The NE2NW2 Sec. 17, Tp. 54 N. R. 84 West of the 6th P.M. which right-of-way and easement is more particularly described as the rights above enumerated over, upon and across a strip of land 15 feet in width, being $7\frac{1}{2}$ feet on each side of the following described center line:

"Beginning at a point on the south line of said NE2 NW2 of Sec. 17; said point being East 445 feet from the Southwest corner of said NE2NW2 of Sec. 17; thence North 2° 18' West, 1364 feet to a point on the North line of said NE2NW2 of Sec. 17."

The Grantors also grant to the Company the right of ingress, egress, or regress, to over, and upon the lands above described for the purpose of constructing, operating, repairing, and maintaining the said electric line; also to trim any trees along said electric line so as to keep the wires thereof cleared for a distance of at least thirty-six inches; and also to erect and maintain necessary guy and brace poles, and anchors, along, or adjacent to, said right-of-way, and to attach thereto the necessary guy wires.

As respects the easement herein granted, the Grantors hereby release and waive all rights under and by virtue of the homestead laws of Wyoming.

Grantors reserve however to themselves title in fee simple to the above described strip of land and all rights, powers and privileges in and to said strip of land not hereinbefore specifically granted by this conveyance.
