ASSIGNMENT, CONVEYANCE AND BILL OF SALE

THIS ASSIGNMENT, CONVEYANCE AND BILL OF SALE (hereinafter called "ASSIGNMENT") is made between SHELL WESTERN E&P INC., a Delaware corporation, having a post office address of Post Office Box 831, Houston, Texas 77001-0831, hereinafter called "SHELL WESTERN," and GENERAL ATLANTIC ENERGY CORPORATION, a Delaware corporation, having an address of 1400 Denver Club Building, 518 17th Street, Denver, Colorado 80202, hereinafter called "GENERAL."

IN CONSIDERATION of the mutual promises made between SHELL WESTERN and GENERAL, SHELL WESTERN hereby grants, assigns, transfers, and conveys to GENERAL, its successors and assigns, without warranty of any kind, express or implied, subject to the terms and conditions contained herein, the following property:

1. All of SHELL WESTERN's right, title, and interest in and to the oil and gas leasehold estates described in EXHIBIT A, attached hereto and made a part of this ASSIGNMENT by incorporation and reference, the same as if fully set out herein,

2. All of SHELL WESTERN's right, title, and interest in and to all permits, franchises, licenses, servitudes, easements, surface leases and rights-of-way, of every character, relating to the property described in EXHIBIT A,

3. All of SHELL WESTERN's right, title, and interest in and to any contracts or agreements including but not limited to rights and interests in or derived from unit agreements, orders and decisions of state and federal regulatory authorities establishing units, gas processing agreements, joint operating agreements, enhanced recovery and injection agreements, boundary or line well agreements, farmout agreements and farmin agreements, options, drilling agreements, exploration agreements, joint bidding agreements, assignments of operating rights, working interests, subleases and rights above or below certain footage depths or geological formations, affecting the property described in EXHIBIT A, and

4. All of SHELL WESTERN's right, title, and interest in and to the machinery, equipment, fixtures and personal property associated or used in the operation of the property described in EXHIBIT A.

THIS ASSIGNMENT shall be subject to the following terms, conditions, or exceptions:

1. THIS ASSIGNMENT shall at all times be subject to the terms, conditions, exceptions, and reservations contained in a certain unrecorded Purchase and Sale Agreement between SHELL WESTERN and GENERAL dated September 30, 1985, and titled "SHELL WESTERN/GENERAL PURCHASE AND SALE AGREEMENT," the terms of which may alter or condition the interests conveyed by this ASSIGNMENT. The unrecorded Purchase and Sale Agreement shall at all times govern the rights of the parties in the property transferred by this ASSIGNMENT, and all interested parties are hereby given notice of its existence.

2. This ASSIGNMENT shall be effective as of 7:00 a.m., July 1, 1985.

3. The terms, conditions or exceptions contained herein shall constitute covenants running with the land, and shall be binding upon, and for the benefit of, the respective successors and assigns of SHELL WESTERN and GENERAL.
