WITNESSETH, that for valuable considerations received, OWNER does hereby grant, bargain, sell and convey unto COMPANY, its auccessors and assigns, an easement 50 feet in width, being 25 feet left, and 25 feet right of the center line as laid out and/or surveyed, or as finally installed on the hereinafter described lands, together with the right to construct, operate, maintain, repair, increase the capacity of, remove, and replace a gas pipeline or lines, including necessary pipes, poles, and fixtures, through, over, under and across the following described real estate, situated in the County of Sheridan , State of Wyoming , namely: A Tract or Strip of land lying th the Northwest Quarter of the Southwest Quarter (NWISWI) of Section Twenty-eight (28), Township Fifty-four (54) North, Range Eighty-three (83) West, of the sixth (6th) Principal Meridian of the following described centerline: Beginning at a point which is North 34°28' East, 2,570.3 feet from the Southwest Corner of said Section 28, thence North 36°32' West, 229.0 feet, thence North 21°05' West, 429.0 feet to a point which is North 89°40' East, 1,038.8 feet from the West Quarter Corner of Section 28.
