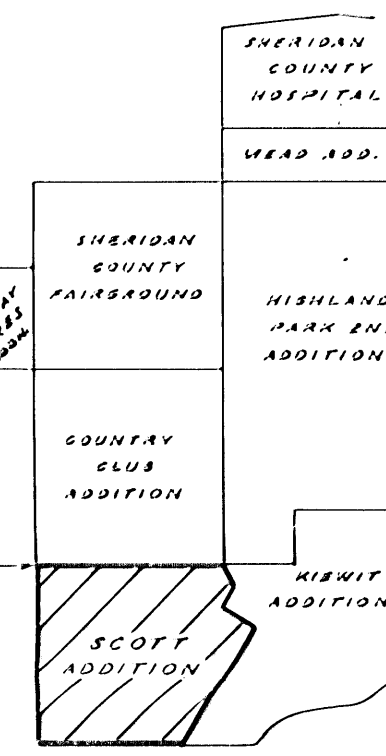

THE BOUNDARIES OF THIS SUBDIVISION WERE SURVEYED THROUGH USE OF A MOORE "B" GONIOMETER AND BY CONVENTIONAL METHODS. ALL INTERIOR ANGLES AND DISTANCES WERE COMPUTED AND LAID OUT BY A PLOTTING COMPUTER SERVICE.
