heirs and assigns, forever, all such right, title, interest, property, possession, claim and demand, as she  
has ~~now~~ or ought to have, in or to all the following described premises, to-wit:

Part of Lot 10 of Paradise Park, a subdivision SW of Sheridan, Wyoming,  
situate in the County of Sheridan, State of Wyoming, more particularly  
described as follows:

Beginning at a point on the SW Corner of Lot 10 of Paradise Park, a Sub-  
division SW of Sheridan, Wyoming; thence North 0°05'30" West a distance  
of 596.3 feet to a point; thence South 84°13'30" East a distance of 552.5  
feet; thence South 29°14' West a distance of 174.8 feet; thence South  
37°44' East a distance of 216.8 feet; thence South 4°30' West a distance  
of 153.4 feet; thence South 52°22' West a distance of 103.7 feet; thence  
South 12°00' West a distance of 84.4 feet; thence North 80°31' West a  
distance of 264.7 feet; thence North 64°35' West a distance of 147.8  
feet; thence South 74°15' West a distance of 92.6 feet to the point of  
beginning.

This Deed is given to correct an error in the description of the prior  
Deed between the same parties hereto dated April 19, 1976 and filed for  
record May 4, 1976 in Book 215 of Deeds at Page 73 in the office of the  
Sheridan County Wyoming Clerk and Recorder of Deeds.

Hereby releasing and waiving all rights under and by virtue of the homestead exemption laws of the  
State of Wyoming.

heirs and assigns, to his and their own proper use and behoof forever. So that neither

nor any other person in her name or behalf, or either of us or any other person in our or either of our

of, but they and every one of them shall by these presents be excluded and forever barred.

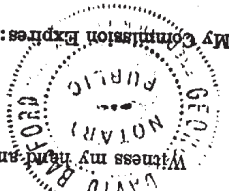
