WITNESSETH, that for valuable consideration received; MORTGAGEE does hereby grant, bargain and convey unto the COMPANY, to successors and assigns, forever, the right, privilege and authority to lay, construct, operate, maintain, repair, replace and remove a gas pipe inc including necessary pipes, poles, and fixtures through, over, under and across the following described real estate, situated in the County of Sheridan State of Wyoming, and does hereby release and waive all rights under and by virtue of the honesteed exemption laws of this state, to wit: A strip of land 50 ft. in width, being 25 ft. on each side of the surveyed conterline across the E/2 of Sec.26 except a tract in said Sec.26 beginning at the corner of said Sec. thence E. 122 ft, thence northwesterly direction 209 ft. to a point on the center line of Sec.26, thence S. 170 ft. to the point of beginning. The E/2 of Section 25; and the Sec.14 all lying and being in Township 55 North, Range 84 West of the 6Th Principal Meridian.

OW THE agrees not to build, create or construct or permit to be built, created, or constructed, sny obstruction, building, engineering works or other structures over, under or that would interfere with seid pipe line or lines or COMFANY'S rights hereunder.

MORTGAGEE hereby grants to the COMPANY, its successors and assigns, the right at all reasonable times to enter upon said premises for the purpose of laying, constructing, maintaining, operating, replacing, repairing or removing said gas pipe line and for the purpose of doing all necessary work in connection therewith.

COMPANY by the acceptance hereof, hereby agrees that it will pay any and all damages that may result to the crops, fences, buildings or improvements on the above described premises, occasioned by constructing, maintaining, replacing, replacing, operating or removing of said gas
