AMENDMENT TO THE DECLARATION OF PROTECTIVE COVENANTS OF TERRA VISTA SUBDIVISION

WITNESSETH:

WHEREAS the Declaration of Protective Covenants for Terra Vista Subdivision were placed of record on July 11, 1975 at Book 209, page 585, instrument no. 667400 in the office of the County Clerk of Sheridan County, Wyoming;

And, whereas said Declaration of Protective Covenants as filed provided that all of the parcels, lots, tracts and portions of Terra Vista Subdivision were to be held, transferred, sold or conveyed subject to the conditions, restrictions, reservations and covenants of record and upon the express provisions, reservations and covenants of the Protective Covenants of Terra Vista Subdivision for the benefit of all parcels, lots, tracts and portions of Terra Vista Subdivision;

And, whereas paragraph 21 of the Declaration of Protective Covenants of Terra Vista Subdivision provides:

These restrictions and covenants may be amended or altered at any time upon the approval of the owner/owners of 75% of the lots in Terra Vista Subdivision.


And, whereas the undersigned, being owners of more than 75% of lots in Terra Vista Subdivision wish to amend the Declaration of Protective Covenants as hereinafter set forth:

NOW, THEREFORE, the Declaration of Protective Covenants of Terra Vista Subdivision shall be and are amended as follows:

Paragraph 23 of the Declaration of Protective Covenants of Terra Vista Subdivision is deleted in its entirety and the following shall be inserted in its place:

(23)

All roads within Terra Vista Subdivision shall be constructed with crushed base material or other suitable surfacing material in coordination with the Woodland Hills Improvement and Service District. All roads within the subdivision shall be maintained in coordination, conjunction and cooperation with the maintenance, improvement and repair of all roads within the Woodland Hills Improvement and Service District, of which Terra Lista Subdivision is a part. The cost of such road maintenance, improvement and repair shall be paid by the property owners of Terra Vista Subdivision according to the assessments of and by the Woodland Hills Improvement and Service District. If for any reason, road maintenance, repair and improvement is performed by Terra Vista Subdivision alone and not by the Woodland Hills Improvement and Service
