## DRAINAGE EASEMENT

THIS DRAINAGE EASEMENT hereinafter granted by BARKER BROS., INC., a Wyoming corporation, hereinafter called Grantor to the CITY OF SHERIDAN, Sheridan, Wyoming, hereinafter called Grantee;

WHEREAS, Grantor is the owner of all of the property hereinafter described in Exhibit "A"; and

WHEREAS, a portion of said lands containing approximately 17.25 acres, more or less, which has been platted by Grantor as the Sheridan Industrial Park Phase 1 to the City of Sheridan, has natural drainage onto other lands owned by Grantor which are not being developed by Grantor and are not part of Phase 1 of the Sheridan Industrial Park; and

WHEREAS, Grantee desires to assure the owners and purchasers of lots within Phase 1, the successors and assigns, the right to continued drainage from their lands; and

WHEREAS, Grantor is willing to grant a general drainage easement unto Grantee for the use and benefit of the purchasers of the lots within Phase 1 of said Sheridan Industrial Park, limited only by the right of Grantor to gather, collect and locate such drainage and transport it across its lands at any location or locations it deems desirable.

NOW, THEREFORE, in consideration of the premises, Grantor does hereby grant and demise unto Grantee a drainage easement across all of the lands described in Exhibit "A", excepting only therefrom that portion of Exhibit "A" which has been platted as the Sheridan Industrial Park Phase 1 and which excepted portion is more particularly described as follows, to-wit:

A tract of land lying in the City of Sheridan, Section 23, Township 56 North, Range 84 West, of the 6th P.M., Sheridan County, Wyoming, more particularly described as follows:

Neither Grantee, nor any of the successors in interest to lots within Phase 1, shall have the right to perpetual general drainage across all the lands described herein.
