Beginning at the NW corner of Section 30, T57N, R83W, 6th P.M., Sheridan County Wyoming (POINT OF BEGINNING); thence bearing approximately N89°30'E for an approximate distance of 100' to a point on the northern boundary of Section 30 where Powder River Energy Corporation's new three-phase overhead power line (Main Line) enters St. Romain property (TRUE POINT OF BEGINNING).

The Main Line continues from this point bearing approximately S38°35'W for an approximate distance of 2300'(entering Section 25, T57N, R84W, 6th P.M., Sheridan County in mid-span), it then "taps" (primary tap) to the west.

The primary tap continues bearing approximately N81°34'W for an approximate distance of 495', where it "taps" (secondary tap) to the north.

The secondary tap continues bearing approximately N15°20'E for an approximate distance of 196' where it terminates at a meter pole.

The primary tap continues from the point of intersection with the secondary tap bearing approximately N81°33°W for an approximate distance of 362°; thence bearing approximately N45°39°W for an approximate distance of 300° where it leaves St. Romain property (POINT OF EGRESS).

The Main Line continues from the point of intersection with the primary tap bearing approximately \$38°36'W for an approximate distance of 1684'; thence bearing approximately \$38°41'W for an approximate distance of 450' where it leaves St. Romain property (POINT OF ENDING); this point being located approximately N52°30'W at an approximate distance of 3340' from the SE corner of Section 25.

The above description is for a three-phase 24.9/14.4kV overhead power line "Right-of-Way", 30' in width, being 15' on either side of centerline extending an approximate total distance of 5687 feet.
