Beginning at the NW corner of Section 30, T57N, R83W, 6th P.M., Sheridan County Wyoming (POINT OF BEGINNING); thence bearing approximately N89°30'E for an approximate distance of 100' to a point on the northern boundary of Section 30 where Powder River Energy Corporation's new three-phase overhead power line (Main Line) enters St. Romain property (TRUE POINT OF BEGINNING).

The Main Line continues from this point bearing approximately S38°35'W for an approximate distance of 2300'(entering Section 25, T57N, R84W, 6th P.M., Sheridan County, in mid-span), the line then "taps" (TAP A) to the west.

Tap A continues bearing approximately N81°34'W for an approximate distance of 495', where it "taps" (TAP B) to the north.

Tap B continues bearing approximately N15°20'E for an approximate distance of 196' where it terminates at a meter pole (END TAP B).

Tap A continues from the point of intersection with Tap B bearing approximately N81°33'W for an approximate distance of 362, where it ties into an existing single-phase power line on St. Romain property (END TAP A).

The Main Line continues from point of intersection with Tap A bearing approximately \$38°36'W for an approximate distance of 2025'; thence bearing approximately \$01°23'W for an approximate distance of 820', where it leaves St. Romain property (POINT OF ENDING); this point being located on an approximate bearing of N64°21'W at an approximate distance of 2910' from the SE corner of Section 25, T57N, R84W, 6th P.M., Sheridan County, Wyoming.

The above description is for a three-phase 24.9/14.4kV overhead power line "Right-of-Way", 30' in width, being 15' on either side of centerline extending an approximate total distance of
