A triangular parcel of land lying at the intersection of the presently existing northwesterly right-of-way boundary of Wyoming State Highway No. 335 and the presently existing easterly right-of-way boundary of Sheridan County Upper Road No. 113 located in the NE¼SW¼ of Section 33, T.55N., R.84W. of the 6th P.M., Wyoming, lying between the presently existing easterly right-of-way boundary of said Sheridan County Upper Road No. 113 and a parallel right-of-way line (or as otherwise stated) when measured radially to the following survey line of highway, said parallel right-of-way line begins on the presently existing easterly right-of-way boundary of said County Road No. 113 and ends on the presently existing northwesterly right-of-way boundary of Wyoming State Highway No. 335:
