## AESTHETIC EASEMENT

WHEREAS, Grantee is the owner of Lots 1, 3 and 3, Block 23, Suburban Homes Company Addition to the City of Sheridan, located in the South ½ Southeast ¼ Section 15 of Township 56 North, Range 84 West, 6<sup>th</sup> P.M., Sheridan County, Wyoming, and that portion of Massey Avenue vacated in Book 55 of Deeds, Page 320, described as follows:

Beginning at the NE corner of Block 24 Suburban Homes Company Addition to the City of Sheridan;

Thence N 67°16'01" E, 60.00 feet along the southerly right-of-way line of Seymour Street to a point being the NW corner of Block 23;

Thence S22°26'10"E, 150,00 feet to the SW corner of Lot 3, Block 23;

Theree S67°16'01" W, 60.00 feet to a point being the SE corner of Lot 15, Block 24;

Theree N 22°26'10" W, 150.00 feet to the point of Beginning. ("Grantee's Land"); and

WHEREAS, Grantor is the owner of Lots 4, 5, and 6, Block 23, Suburban Homes Company Addition to the City of Sheridan, Sheridan County, Wyoming, and that portion of Massey Avenue vacated in Book 55 of Deeds, Page 320, which lies adjacent to and West of Lots 4, 5, and 6, Block 23, Suburban Homes Company Addition to the Town, now City, or Sheridan, Wyoming ("Grantor's Land"); and

WHEREAS, Grantor wishes to convey to Grantee an Aesthetic Easement upon Grantor's Land for purposes of maintaining a landscaped separation between the Grantor's Land and the Grantee's Land, such Easement to benefit Grantee's Land.

NOW, THEREFORE, for good and valuable consideration, including the mutual promises and covenants contained herein, it is agreed by and among the parties as follows:

## 1. Grant of Easement

Grantor does hereby grant and convey to Grantee, and the heirs, successors and assigns of Grantee, releasing and waiving all rights under and by virtue of the Homestead Exemption Laws of this State, a perpetual Aesthetic Easement upon Grantor's Land for purposes of maintaining a landscaped separation between the Grantor's Land and the Grantee's Land.

## 2. Description of Easement

The Aesthetic Easement granted herein is located upon the Grantor's Land, and is more particularly described as follows:

A 15.00 foot wide easement located along the North line of Lot 4, Block 23, Suburban Homes Company Addition to the City of Sheridan, Sheridan County, Wyoming, said 15.00 foot wide easement being adjacent to the South line of Lot 3, Block 23, Suburban Homes Company Addition to the City of Sheridan, Sheridan County, Wyoming, said easement being 15' x 140'.

## 3 Additional Terms

- A. This Easement shall inure to the benefit of Grantee, and their heirs, successors and assigns forever, and shall be binding upon Grantors, and their respective heirs, successors and assigns, forever, and shall be a covenant that shall run with the land.
- B. The Easement created by this instrument shall not preclude Grantor's use of Grantor's property, except to the extent that Grantor shall not in any way and at any time obstruct the Easement or otherwise interfere with Grantee's rights to use the easement for the purposes allowed by this instrument.
- C. Grantee, and Grantee's heirs, successors and assigns, shall, at their sole and exclusive expense, maintain the Aesthetic Easement in a well-landscaped and groomed manner.
