WITNESSETH, that for valuable considerations received, OWNER does hereby grant, bargain, sell and convey unto COMPANY, its successors and assigns, an easement 15 feet in width, being 7.5 feet left, and 7.5 feet right of the center line as laid out and/or surveyed, or as finally installed on the hereinafter described lands, together with the right to construct, reconstruct, operate, maintain, repair, remove and replace a gas pipeline or lines, including necessary pipes, poles, and fixtures, and a buried or semiburied electric distribution system, street lighting system, or any combination thereof including the necessary cables, pedestals, transformers, transformer bases and other fixtures and apparatus in connection therewith through, over, under, and across the following described real estate, situated in the County of Sheridan, State of Wyoming, namely:

No Overhead Times allowed.

An underground electric line easement fifteen (15) feet wide, being seven and one half (7.5) feet each side of the following described centerline being more particularly described as follows:

Commencing at the west quarter corner of said Section 15 (Monumented with a 1½" Aluminum Cap per PE&LS 2614); thence S59 ° 27'15"E, 2441.45 feet to the **POINT OF BEGINNING**, said point lying on the west line of a tract of land described in Book 327 of Deeds, Page 475, said point also lying on the centerline of Upper Prairie Dog Road (AKA County Road No. 127); thence N09 ° 51'48"E, 99.50 feet along the centerline of said easement to a point; thence N36 ° 45'47"E, 254.98 feet along said centerline to a point; thence N13 ° 13'19"E, 403.83 feet along said centerline to a point; thence N02 ° 04'21"W, 395.66 feet along said centerline to a point; thence N37 ° 33'25"W, 42.67 feet to the **POINT OF TERMINUS**, said point lying on the north line of said tract described in Book 327 of Deeds, Page 475 and being S87 ° 08'21"E, 2327.24 feet from said west quarter corner of Section 15.

OWNER agrees not to build, create or construct or permit to be built, created, or constructed, any obstruction, building, engineering works or other structures over, under, or that would interfere with said underground lines or COMPANY'S rights hereunder.

OWNER hereby grants to COMPANY, its successors and assigns, the right at all reasonable times to enter upon said premises for purpose of laving, constructing, maintaining, operating, replacing, repairing or removing said underground lines and for the

COMPANY by the acceptance hereof, hereby agrees that it will pay any and all damages that may result, including crops, fences, buildings and improvements on said premises, caused by constructing, maintaining, repairing, operating, replacing or removing said company and one by OWNER; these two shall select the third person. The award of these three persons shall be final and

If the herein described lands are in the State of Wyoming, OWNER does hereby release and waive all rights under and by virtue of the homestead exemption laws of that state.
