KAMRAN-KOHNJANI, husband and wife 138 North Main Street Sheridan, Wyoming 82801 WITNESSETH, that for valuable considerations received, OWNER does hereby grant, bargain, sell and convey unto COMPANY, its successors and assigns, an easement 50 feet in width, being 25 feet left, and 25 feet right of the center line as laid out and/or surveyed, or as finally installed on the hereinafter described lands, together with the right to construct, operate, maintain, repair, increase the capacity of, remove, and replace a gas pipeline or lines, including necessary pipes, poles, and fixtures, through, over, under and across the following described real estate, situated in the County of Sheridan, State of Wyoming, namely:

A Tract or Strip of land lying in the Northwest Quarter of the Southeast Quarter (NW\SE\) of Section Seven (7), Township Fifty-four (54) North, Range Eighty-three (83) West, in the sixth (6th) Principal Meridian, said strip of land being Fifty (50) feet wide, Twenty-five (25) feet on each side of the following described centerline: Beginning at a point which is North 13°54' East, 1,956.4 feet from the South Quarter Corner of said Section 7, thence North 30°24' West, 420.0 , thence North 11°07' West, 500.0 feet to a point which is North 3°21' East, 2.756.6 feet from the South Quarter Corner of Section 7.
