for a good and valuable consideration, the receipt whereof is hereby acknowledged, do hereby grant easement unto THE RANGE TELEPHONE COOPERATIVE, INC., whose post office address is Forsyth, Montana 59327, and to its successors or assigns, the right to enter upon the lands of the undersigned, situated in the county of <a href="Meridan">Sheridan</a>, state of <a href="Wyoming">Wyoming</a>, and more particularly described as follows:

## Township 55 North, Range 79 West 6th P.M.

Section 23: SESESWSW, E2SW, N2N2SE, S2S2NE

Section 26: W2SE, SWNE, E2NW, NENENWNW

Section 35: All those portions of the N2NE4 and SWNE lying North and West of the Southeasterly right-of-way of the Chicago, Burlington and Quincy railroad being more particurly described in Book 492 on Page 380 as recorded in the Sheridan county courthouse in Sheridan, WY.

The easement shall be located on the following portions of said property:

A 20' right-of-way in and through, the above mentioned land description as shown on Exhibit "A", for buried telecommunications cables.

To construct, reconstruct, operate and maintain on or under the above-described lands and/or in, upon or under all streets, roads, or highways, abutting said lands, a telephone line or system, to cut and trim trees and shrubbery that may interfere with or threaten to endanger the operation and maintenance of said line or system.

The undersigned agrees that all poles, wires and other facilities, including all telephone equipment, installed on the above-described premises at the Company's expense, shall remain the property of the Company, removable at the option of the Company.
