DECREE OF DISTRIBUTION

This cause came on regularly to be heard this day upon the Final Account and Petition for Distribution, which was filed herein by William D. Redle, as Executor of the Estate of Vernon S. Griffith, deceased, and it appearing to the Court, that Notice of Final Settlement of said estate has been published in the manner provided by law, and that proof thereof has been filed in this Court, and that due and legal notice of the time and place of hearing upon said Final Account and Petition for Distribution has been given as required by law, and said Final Account and Petition for Distribution being now presented to the Court, and no person having filed objection thereto, and it appearing that so far as known, all taxes upon the property of said estate, have been fully paid; that a Report has been made to the Inheritance Tax Commissioner of the State of Wyoming, and that said Commissioner has issued his Certificate and Receipt showing that all inheritance taxes due and payable from said estate to the State of Wyoming, have been fully paid.

And it further appearing to the Court, that a Federal Estate Tax Return has been prepared and filed with the District Director of Internal Revenue for the District of Wyoming, and that all Federal Estate Taxes due and payable

from said estate, have been paid so far as the same have been determined, and that in the event additional Estate Tax is found to be due and payable from said Estate, The Vernon S. and Rowena W. Griffith Foundation, which is the residuary legatee under said will, will be charged with the responsibility of paying such additional tax.

And it also appearing to the Court, that all claims which were presented to the Executor, have been fully paid, and that no claims remain unpaid, and that the time within which claims could be filed has expired, and that all obligations owing by said estate have been fully paid.

And it further appearing to the Court, that under date of February 20, 1976, this Court entered its Order authorizing payment of the legacy in the amount of Ten Thousand Dollars (\$10,000.00) to St. Peter's Episcopal Church of Sheridan, Wyoming, and that a Receipt dated February 25, 1976 indicating full payment thereof, is on file in said probate.

It further appearing to the Court, that on October 15, 1976, this Court entered a Decree of Partial Distribution, by which the following described real property, to-wit:

Lots 1 and 2, Block 2, of Grand View Addition to the City of Sheridan, Sheridan County, Wyoming, together with the improvements situate thereon, and all household furnishings and effects found therein,

was distributed and set over to Winifred Bergen, sister of the Testator, and title thereto confirmed in said Winifred Bergen.

And it further appearing to the Court, that this Court, by its Order entered December 6, 1976, determined the Attorney fees to be allowed the firm of Redle, Yonkee & Arney, for legal services rendered in said estate and that

the only expense of administration that remains unpaid, is the accounting fee due John L. Byrtus, Certified Public Accountant, and that said John L. Byrtus has presented your Executor with a statement, by which he claims a total fee in the amount of \$4,635.00 for all accounting services rendered in said estate, and that said fee is reasonable in view of the services rendered, and that said fee should be paid.

It further appearing to the Court, that said estate has been fully administered upon, and that the residue and remainder of said estate, which is hereinafter described is ready for distribution, and that under Paragraph FOURTH of the Last Will and Testament of said Vernon S. Griffith, the Testator gives, devises and bequeaths all of the residue and remainder of his estate, real, personal and mixed, of whatsoever kind and character the same may be and wheresoever situate, of which he died possessed or to which he was entitled, to THE VERNON S. AND ROWENA W. GRIFFITH FOUNDATION, a Wyoming Corporation which has its principal office situate in the City of Sheridan, County of Sheridan, State of Wyoming.

It further appearing to the Court, that The Vernon S. and Rowena W. Griffith Foundation is a duly qualified and existing charitable Foundation created and organized under the Laws of the State of Wyoming, and is in good standing at this time.

IT IS, THEREFORE, HEREBY ORDERED, ADJUDGED AND DECREED by the Court, that the Final Account and Petition for Distribution which was filed herein, be and the same is hereby in all things, settled, allowed, approved and confirmed.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED by the Court, that the Executor forthwith pay to John L. Byrtus,

Certified Public Accountant, the sum of Four Thousand, six Hundred Thirty-five Dollars (\$4,635.00) in full of accounting fees due for accounting services rendered to said Executor and said estate.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED by the Court, that Vernon S. Griffith died testate in Sheridan County, Wyoming on January 10, 1976, and that at the time of his death, he was a resident of the County of Sheridan, State of Wyoming and that in accordance with the terms and provisions of the Last Will and Testament of said Testator, all of the residue of said estate, real, personal and mixed, of whatsoever kind and character the same may be and wheresoever situate, including all property which belonged to said deceased at the time of his death, or in which he had any interest, real or personal, whether described herein or not, be and the same is hereby distributed and set over to "THE VERNON S. AND ROWENA W. GRIFFITH FOUNDATION", a Wyoming Corporation, for the purposes and objects of said Foundation. That included in the property so distributed to, set over and vested in The Vernon S. and Rowena W. Griffith Foundation, a Wyoming Corporation, is the following real and personal property, to-wit:
