DEDICATION


Quitclaim deed made May 10, 1977, between WOODROW WILSON and JUANITA J. WILSON, of Sheridan County, Wyoming, herein referred to as dedicators, and the County of Sheridan, State of Wyoming, acting by and through the Board of County Commissioners of Sheridan County, Wyoming, herein referred to as dedicatees.

Dedicators, do hereby dedicate, release, remise and quitclaim to dedicatee, to have and to hold for the public use the roads shown on the plat of Eastern Hills Subdivision, which is recorded in Book 1 of Plats at page 106, in the office of the County Clerk, Sheridan County, Wyoming, which is a subdivision of the following described land, particularly described as situated in the:

N $\frac{1}{4}$ SW $\frac{1}{4}$ and the S $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 1, Township 55 North, Range 84 West, Sixth Principal Meridian, Wyoming, whose point of beginning is on the South right of way line of U.S. Highway #14, N 5°20'W, a distance of 3203.7 feet from the monumented corner for the South $\frac{1}{4}$ corner of said Section 1, T 55 N, R 84 W; thence S 10°36.5'E, a distance of 318.6'; thence S 4°06'E along a chord of a 975' radius curve, for a distance of 232.5'; thence S 2°25'W for a distance of 32.4'; thence S 3°09'E along a chord of a 1025' radius curve for 189.4'; thence S 8°44'E, a distance of 65.7'; thence S 4°57'E, a distance of 356.2'; thence S 89°30'W, a distance of 252.1'; thence S 75°38'W, a distance of 304.8'; thence N 82°58'W, a distance of 260.6'; thence N 65°09'W, a distance of 295.7'; thence N 61°01'W, a distance of 184.9'; thence N 1°20'E, a distance of 688.0'; thence S 89°30'E, a distance of 395.3'; thence N 6°17'E, a distance of 686.9' to the South right of way line of U.S. Highway #14; thence along the South right of way line of U.S. Highway #14 for a distance of 715.3' with a bearing of S 60°49'E to point of beginning.


