5. Plaintiff should recover judgment against the defendant, for relief demanded in the complaint.

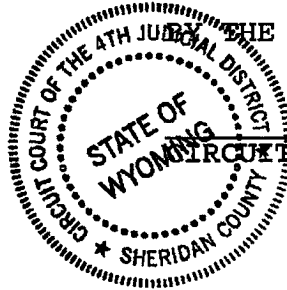
