AGREEMENT TO AMEND MORTGAGE

THIS AGREEMENT is made and entered into this M day of November 2007, by and between Sharilyn L. Chapman, formerly known as Sharilyn L. Schmidt, and Richard L. Wrather, Sr. and Laura A. Wrather. All such sums so paid shall draw interest at the same rate.
