AGREEMENT

AGREEMENT entered this 22nd day of June, 1976, by and between Elmer J. Mydland and wife, Suzanne Mydland; Mervin Jordan Mydland and wife, Susan Mydland; and Elmer Milton Mydland, hereinafter designated "GRANTORS", and Shell Oil Company, a Delaware corporation, whose address is P. O. Box 2099, Houston, Texas 77001, hereinafter designated "GRANTEE".

WHEREAS, by instrument dated August 18, 1975, recorded in Book \_\_\_\_\_, page \_\_\_\_\_ of the deed records of Sheridan County, Wyoming, GRANTORS did grant and convey unto GRANTEE a permanent right-of-way and easement for railroad purposes over, upon, in and across the following described lands in Sheridan County, Wyoming, to-wit:

Township 57 North - Range 83 West, 6th P.M.

Section 7: W/2 NE/4, N/2 SE/4, SE/4 SE/4

Section 8: W/2

together with certain rights, powers and privileges appurtenant thereto, and described therein; and

WHEREAS, by the terms of the aforesaid instrument GRANTEE agreed to furnish a specific description of the right of way and easement to GRANTORS for approval at least sixty (60) days prior to commencement of operations for construction of the railroad; and

WHEREAS, the aforesaid right of way Easement, as well as a certain right of way Agreement of the same date were deposited with The First National Bank of Sheridan, Wyoming as escrow agent in accordance with the provisions of a certain Escrow Agreement dated August 18, 1975, received and executed by the escrow agent October 23, 1975; and

WHEREAS, the escrow agent was directed to deliver the right of way Easement and right of way Agreement to GRANTEE upon

deposit of certain sums as specified in the Escrow Agreement, on or before July 31, 1976; and

WHEREAS, it is necessary to fix and ascertain both the acreage and length of the right of way Easement across GRANTORS' land in order to determine the sums to be deposited with the escrow agent, which sums are the consideration for the Easement and Agreement.

NOW THEREFORE, in consideration of the premises, GRANTEE hereby furnishes, and GRANTORS hereby approve, the specific description of the right of way easement as set forth in the attached Exhibit A and Plat of Railroad R.O.W. Survey. For the purposes herein expressed, said easement is deemed to total 33.86 acres, and 7357.36 feet in length, across the lands described above, whether in fact more or less.

AND GRANTORS, for themselves, their heirs, devisees, personal representatives, successors and assigns hereby approve, ratify, confirm, grant and convey the right of way easement described herein, subject to the terms and provisions of the instruments referred to above.
