and to place, construct, operate, repair, maintain, relocate and re-
place thereon and in or upon all streets, roads or highways abutting
said lands an electric transmission or distribution line or system,
and to cut and trim trees and shrubbery to the extent necessary to
keep them clear of said electric line or system and to cut down from
time to time all dead, weak, leaning or dangerous trees that are tall
enough to strike the wires in falling.

In granting this easement it is understood that at pole locations,
only single pole and appurtenances will be used, and that the location
of the poles will be such as to form the least possible interference
to farm operations, so long as it does not materially increase the
cost of construction.

The undersigned covenants that he is the owner of the above de-
scribed lands and that the said lands are free and clear of encumbran-
ces and liens of whatsoever character except those held by the follow-
ing persons:
