<u>Consideration of VAR 1-11-2046</u>; Patio Homes at Woodland Park; a variance request from the 5' side yard setback requirement for an R-3 Residential District to allow a zero (0) side yard setback for duplex construction on 5.5 acres. Patio Homes @ Woodland Park, lots 1-36.

This request was granted.

The motion of the Board of Adjustments approves a variance request from the 5' side yard setback requirement for an R-3 Residential District to allow a zero (0) side yard setback for duplex construction of 5.5 acres with the following conditions.

- The variance would apply to all lots in the subdivision and all other setback requirements are to be followed.
- 2. All dwellings use a single common road.
- Approval of the Subdivision by City Council.

Findings for this request were as follows:

- Granting a variance from side yard setback requirements is preferable to creating a Planned Unit Development solely for a single variance request.
- Granting the variance is not contrary to the public interest, and is in harmony with the spirit of the zoning ordinance, as long as the property owner complies with other aspects of the zoning ordinance.
