TRANSFER ON DEATH DEED

- 2. One-half interest to **Chelsie Moncecchi**, born August 29, 1989, 822 Victoria Street, Sheridan, Wyoming 82801.

If Sabina Szatkowski and her two daughters Haley Patterson and Chelsie Moncecchi predecease Rita I. Taylor, formerly Rita I. Sampson, the conveyance shall be void and the property shall become part of the estate of the Owner.
