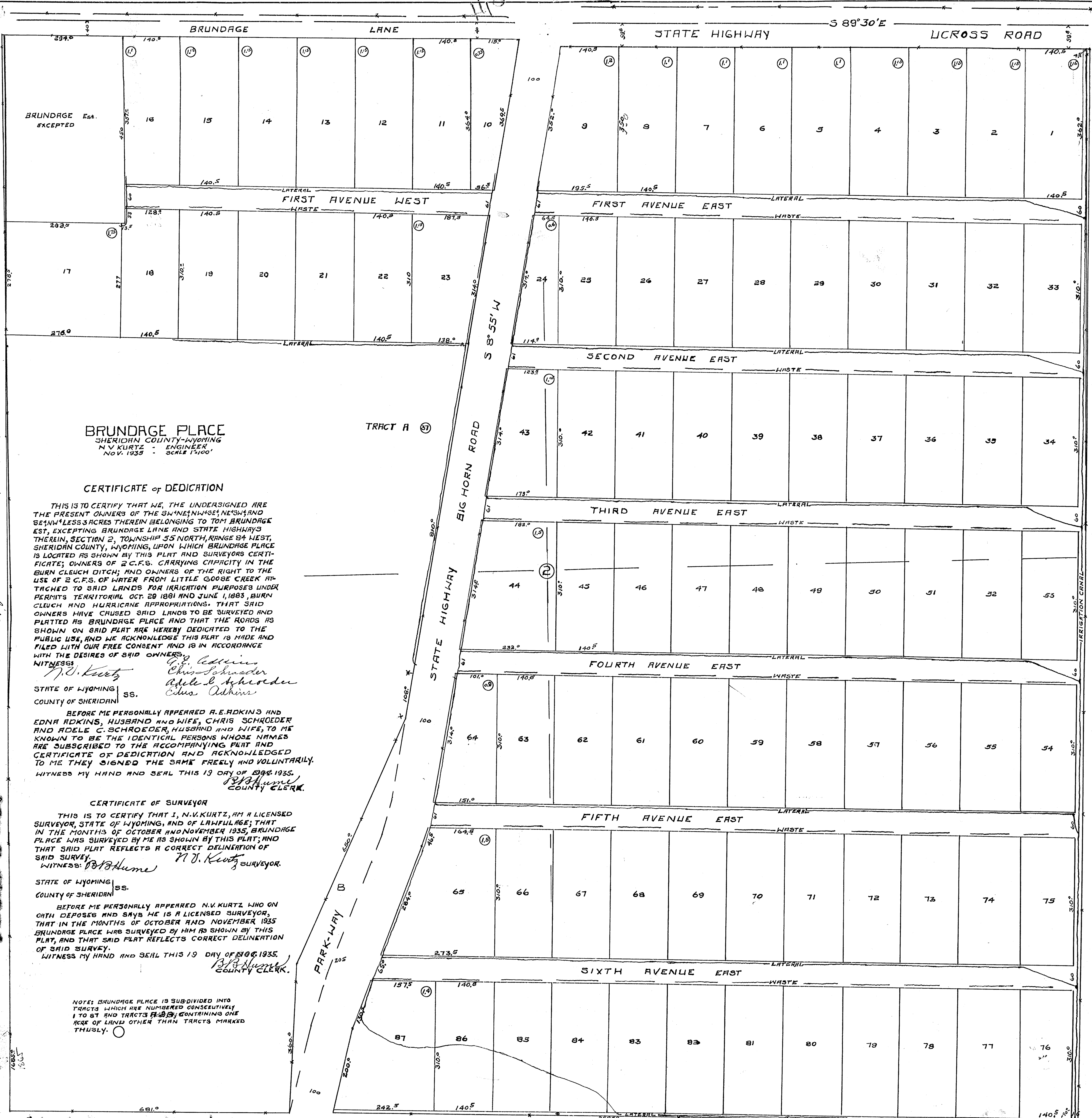

#### CERTIFICATE OF DEDICATION

THIS IS TO CERTIFY THAT WE, THE UNDERSIGNED ARE THE PRESENT OWNERS OF THE SWINEY, N.W. 1/4, AND SE 1/4, N.W. 1/4, S. 34, T. 55 N., R. 84 W., SHERIDAN COUNTY, WYOMING, UPON WHICH BRUNDAGE PLACE IS LOCATED AS SHOWN BY THIS PLAT AND SURVEYORS CERTIFICATE; OWNERS OF 2 C.F.S. CARRYING CAPACITY IN THE BURN CLEUCH DITCH; AND OWNERS OF THE RIGHT TO THE USE OF 2 C.F.S. OF WATER FROM LITTLE GOOSE CREEK ATTACHED TO SAID LANDS FOR IRRIGATION PURPOSES UNDER PERMITS TERRITORIAL OCT. 29 1881 AND JUNE 1, 1883, BURN CLEUCH AND HURRICANE APPROPRIATIONS. THAT SAID OWNERS HAVE CAUSED SAID LANDS TO BE SURVEYED AND PLATTED AS BRUNDAGE PLACE AND THAT THE ROADS AS SHOWN ON SAID PLAT ARE HEREBY DEDICATED TO THE PUBLIC USE, AND WE ACKNOWLEDGE THIS PLAT IS MADE AND FILED WITH OUR FREE CONSENT AND IS IN ACCORDANCE WITH THE DESIRES OF SAID OWNERS.
