# AGREEMENT FOR RIGHT-OF-WAY EASEMENTS AND CONSTRUCTION EASEMENT

THIS AGREEMENT is by and between <u>HEIGHTS DEVELOPMENT CORP.</u>, hereinafter referred to as the Property Owner, and <u>SHERIDAN COUNTY</u>, <u>WYOMING</u>, hereinafter referred to as the County.

WHEREAS, the County proposes to improve County Road No. 80 by reconstructing and realigning approximately 1.04 miles of County Road 80, also known as Mydland Road;

AND WHEREAS, the Property Owner is willing to convey to the County the necessary permanent right-of-way easement, and temporary construction easements,;

NOW THEREFORE, in consideration of mutual covenants set forth herein and for other good and valuable consideration, the parties agree as follows:

- 1. Property Owner agrees to convey unto the County new permanent right-of-way easements on property situated in the NE¼SW¼ and the SE¼NW¼ of Section 21, Township 56 North, Range 84 West, 6th P.M., City of Sheridan, Sheridan County, Wyoming, as described on attached Exhibit "A."
- 2. Property Owner agrees to convey a temporary construction easement on property situated in the NE¼SW¼ and the SE¼NW¼ of Section 21, Township 56 North, Range 84 West, 6th P.M., City of Sheridan, Sheridan County, Wyoming as described on attached Exhibit "B". The temporary easement will be in effect until the contractor's one year contractual warranty expires.
- 3. The County will have the new right-of-way surveyed before the contractor's one year contractual warranty expires.
- 4. The County shall place Temporary Fence (45" 3 barbed wire) along the construction easement. The temporary fence shall become the property of the land owner following construction. Right-of-Way will be fenced with Permanent Fence Type A [32" welded wire and 2 barbed wire (48" total), wood posts].
- 5. The County will seed all disturbed areas in the Right of Way and construction easement with a dryland seed mix.
