NOTICE OF WATER SERVICE PERMIT

The Sheridan Area Water Supply Joint Powers Board hereby gives notice that Water Service Permit Number 192 has been approved and issued to: JOHN MCWILLIAMS AND MARY ELLEN MCWILLIAMS, 1004 BIG GOOSE ROAD, SHERIDAN, WYOMING 82801. Said permit pertains to a parcel of real property situate in Sheridan County, Wyoming, to-wit:

The E1/2NW1/4, and the W1/2NE1/4 of Section 17; and that part of the SW1/4SE1/4 of Section 8, Township 55 North, Range 85 West of the 6th P.M., described as follows; Beginning at a point 977 feet South of the Northeast corner of the Southwest quarter of the Southeast quarter of said Section; thence in a southwesterly direction up the main channel of Big Goose Creek, a distance of 678 feet, more or less; thence meandering in a northwesterly direction up the center of the main channel of said creek to a point on the west boundary line of said Southwest quarter of the Southeast quarter, said point being 350 feet north of the quarter section corner on the south line of said Section 8; thence south to the Southeast corner of said Southwest quarter of the Southeast quarter, thence east to the Southeast corner of said Southwest quarter of the Southeast quarter; and thence north to the point of beginning; EXCEPT that portion of the SE1/4NW1/4 and the SW1/4NE1/4 of Section 17, T55N, R85W, 6th P.M., conveyed by Warranty Deed to Marcia McWilliams Bystrom recorded March 8, 1985 in Book 292 of Deeds, Page 68, as Instrument No. 924272.

Said permit is subject to the terms and conditions of that certain Application for Water Service Permit dated APRIL 11, 1989, as recorded and filed in the offices of the Sheridan Area Water Supply Joint Powers Board.
