CERTIFICATE OF PARTIAL VACATION OF EASEMENT

WHEREAS, Jonathan Scott and Jennifer R. Scott, husband and wife, (herein the "Owner"), are the sole record owners of the following described real property, to wit:

Lots 1, 2, 4 and 5, Block AA, Powder Horn Ranch-2, Planned Unit Development Phase One, a subdivision in Sheridan County, Wyoming, filed as Plat #P-64 (herein the "Property");

The undersigned further declare that the Easement above described, is hereby vacated and of no further force and effect.

THEREFORE, Owners hereby vacate that portion of the easements described and as terminated in accordance with the approval and consent of the County Commissioners of Sheridan County, Wyoming. Owner, by these presents, does make the above vacation for it and for its successors and assigns, and for all future owners of said Property, as the same shall remain as platted — Lots 1, 2, 4 and 5 of the Powder Horn Ranch-2, Planned Unit Development Phase One, but with all utility easements therein vacated.
