THIS MATTER having come before the Court on Plaintiff's Application For Default against the Defendant, and this Court having considered the record and being fully advised in the premises finds as follows:

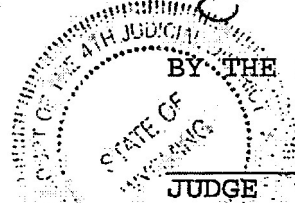
1. The above-named Defendant(s) was(were) personally served with a copy of the Summons and Complaint;
