ORDER ON PLAINTIFF'S MOTION TO CORRECT OR AMEND DECREE OF DIVORCE

NOW on this <u>31</u> day of July, 2020, come the parties, with their respective counsel, on Plaintiff's Motion to Correct or Amend Decree of Divorce entered in this matter on May 31, 2019. Upon that hearing, the Court makes the following findings and orders:

- 1. In its Decree of Divorce, this Court awarded certain livestock including cattle, to the Plaintiff.
- 2. There was evidence before the court at the trial in this matter indicating that there was a 2018 and 2019 calf crop, however, the court makes no further order in regard to the livestock.
- 3. Plaintiff was also awarded certain real property in the Court's May, 2019

 Decree. The Decree does not contain a legal description of that real property so that

 Plaintiff may record the Decree and transfer title to herself. Therefore, the Court sets aside to the Plaintiff the following described real property consistent with its Decree of May 31, 2019:
