A G R E E M E N T

Agreement made this 15<sup>th</sup> day of September, 1977, between  
Lonnie L. Reed, Glenna M. Reed, Leonard L. Reed, Jr., Joyce  
K. Reed, Edward James Knudson, Anthony R. Wiley, Lynnelle  
I. Wiley, William L. Abel and Betty J. Abel.

Whereas, Lonnie L. Reed, Glenna M. Reed, Leonard L.  
Reed, Jr. and Joyce K. Reed, dedicated a one quarter interest  
in the water well located on lot three and four to the  
owners of lots 1, 2, 3 and 4 of the Resubdivision of Tract  
12 of the McNally Subdivision and;

Whereas, said well was inadequate for the needs of the  
residents for said subdivision;

It is hereby agreed that:

1. That Lonnie L. Reed, Glenna M. Reed, Leonard L.  
Reed, Jr. and Joyce K. Reed have caused a new well to be  
drilled located in tract number 3 of the Reed Resubdivision  
of Tract 12 of the McNally subdivision. The well is designated  
as Reed Water Well Number 2.

2. The owners of each tract shall own a one quarter  
interest in the water well located on tract 3 designated as  
Reed Water Well Number 2 and a one quarter interest in the  
pump and all common water lines.

3. The owners of tracts one, two and four shall have  
an easement over tract three for all necessary equipment,  
water lines and power lines necessary for the maintenance of  
the common water system.

4. The owners of each tract agree to substitute Reed  
Water Well Number 2 for the well in tract three and four  
listed in the covenant 10 for the Reed Resubdivision of  
Tract 12 of the McNally Subdivision and to abide by covenant  
10 of the restrictive covenants.

5. It is agreed that Reed Water Well Number 2 is  
presently providing sufficient water for one family dwelling  
on each tract and Lonnie L. Reed, Glenna M. Reed, Leonard L.  
Reed, Jr. and Joyce K. Reed do not guarantee the duration of  
the well. Any further wells shall be drilled pursuant to  
covenant 10 of the protective restrictions of the subdivision.
