AMENDMENT TO DECLARATION OF PROTECTIVE COVENANTS FOR SPARROW HAWK HILL TWO

The undersigned hereby amend the Declaration of Protective Covenants for Sparrow Hawk Hill Two which is recorded in Book 249 of DEEDS at page 410 in the Office of the County Clerk and Ex-Officio Register of Deeds of Sheridan County, Wyoming, to insert the following additional covenant which is imposed upon the lands upon the same terms and conditions as is set forth in the Declaration of Protective Covenants for Sparrow Hawk Hill Two:

The area within the 25 foot building setback line on Lots 5, 6, 7, 8, 9, and 10 as shown on the plat of Sparrow Hawk Hill Two, the easterly 8 feet of Lot 9, and the westerly 7 feet of Lot 10, are hereby dedicated as areas for drainage easements. Within those areas, no structures, planting or other materials shall be placed or permitted to remain which may damage or interfere or change the direction of flow of drainage channels in the easement or which may obstruct or retard the flow of water through the easement area. The easement area of each lot and all improvements in it shall be maintained continuously by the owner of the lot, except for those improvements for which a public authority is responsible.
