## ACCESS AND ELECTRIC LINE EASEMENT

Patrick Hayworth and JoAnn Hayworth, husband and wife, GRANTORS, for and in consideration of the sum of Ten and 00/100 Dollars (\$10.00) and other good and valuable consideration the receipt of which is hereby acknowledged, do hereby grant and convey:

(1) an access easement over and across that land more specifically described, as follows:

A forty (40) foot wide access easement being twenty (20) feet each side of an existing road centerline situated in the NW¼SW¼ and the SW¼NW¼ of Section 5, Township 57 North, Range 85 West, 6th P.M., Sheridan County, Wyoming; said centerline being more particularly described as follows:

Commencing at the West quarter corner of said Section 5 (monumented with a 3" brass cap per PE & LS 537); thence S77°20'39"E, 399.86 feet to the point of intersection with said existing road centerline and the Early Creek Road (AKA Co. Rd. #97) being the **POINT OF BEGINNING** of said easement; thence N39°23'35"W, 201.05 feet along said centerline to a point; thence N48°07'27"W, 233.44 feet along said centerline to a point; thence N51°08'01"W, 115.74 feet along said centerline to a point lying on the west line of said Section 5 being the **POINT OF TERMINUS** of said easement and being N00°16'09"W, 296.23 feet from said West quarter corner of Section 5.

Lengthening or shortening the side line of said easement to intersect said boundary lines.

Bearings are Based on the Wyoming Coordinate System, NAD 1983, East Central Zone

Distances are adjusted to surface by the Datum Adjustment Factor of 1.000248. (the "Access Easement Route"); and

(2) an electric line easement over and across that land more specifically described as follows:

A twenty (20) foot wide electric line easement being ten (10) feet each side of an existing powerline situated in the SW¼NW¼ of Section 5, Township 57 North, Range 85 West, 6th P.M., Sheridan County, Wyoming; said centerline being more particularly described as follows:

Commencing at the West quarter corner of said Section 5 (monumented with a 3" brass cap per PE & LS 537); thence N07°58'38"E, 553.10 feet to the point of intersection with said powerline and the main transmission line along Early Creek Road (AKA Co. Rd. #97) being the **POINT OF BEGINNING** of said easement; thence S76°12'04"W, 81.60 feet along said centerline to a point on the west line of said Section 4 being the **POINT OF TERMINUS** of said easement and being N00°16'09"W, 528.29 feet from said West quarter corner of Section 5.

Lengthening or shortening the side line of said easement to intersect said boundary lines.

The Easement Routes shall forever hereafter be appurtenant to the Dominant Parcel to serve as ingress, egress and utility access for the owners of the Dominant Parcel.

Grantor shall bear no responsibility or liability to any person or entity using the Easement Route by reason of this easement.
