

Re: Annexation to the Town of Ranchester

A tract of land situated in the Wyoming Log Home Estates Subdivision, located in the N½NE¾ of Section 24, Township 57 North, Range 86 West, 6th P.M., Sheridan County, Wyoming, as shown on **EXHIBIT "B"** attached hereto and by this reference made a part hereof; said tract of land being more particularly described as follows:

BEGINNING at the northeast corner of said Wyoming Log Home Estates Subdivision; thence S00°33'20"W, 45.35 feet along the east line of said Wyoming Log Home Estates Subdivision and the east right-of-way line of Kukuchka Lane to a point, said point lying on the south line of said N½NE½; thence S89°36'08"W, 60.01 feet along said south line of said N½NE½ to a point, said point lying on the east line of Lot 7, Wyoming Log Home Estates Subdivision; thence, continue S89°36'08"W, 156.57 feet along said south line of said N½NE½ to a point, said point lying on the southerly right-of-way line of U.S. Highway No. 14; thence, along said southerly right-of-way line through a non-tangent curve to the left, having a radius of 3869.72 feet, a central angle of 02°22'20", an arc length of 160.23 feet, a chord bearing of N78°16'32"E, and a chord length of 160.22 feet to a point, said point being the northeast corner of said Lot 7, Wyoming Log Home Estates Subdivision; thence, continue along said southerly right-of-way line through a curve to the left, having a radius of 3869.72 feet, a central angle of 00°54'55", an arc length of 61.82 feet, a chord bearing of N76°37'54"E, and a chord length of 61.82 feet to the POINT OF BEGINNING of said tract.

Said tract contains 4,674 square feet of land, more or less. Bearings are Based on the Wyoming Coordinate System, NAD 1983, East Central Zone.




