## ORDER APPROVING FINAL REPORT, ACCOUNTING, AND DECREE OF DISTRIBUTION

**THIS MATTER** having come before the Court upon the *Final Report, Accounting and Petition for Distribution* filed herein by Kelley C. Pelissier, Personal Representative of the estate, as required by W. S. § 2-7-811; the Court having considered the *Final Report, Accounting and Petition for Distribution* and the matters filed in this Court, and now being fully advised in the premises, the Court finds and concludes that:

This Court has jurisdiction over the subject matter and all interested parties; all of the statements made in the *Final Report, Accounting and Petition for Distribution* are true and correct; the Personal Representative and the attorneys for the estate have fully and properly administered the estate in accordance with law and in accordance with all duties which they owe to the estate and to the beneficiaries of the estate; the administration of the estate is fully and finally concluded; the estate is ready for distribution; the *Final Report, Accounting and Petition for Final Distribution* was mailed to the beneficiaries named in the Will of decedent; the beneficiaries have waived further accounting and notice of hearing upon said *Final Report, Accounting and Petition for Distribution* in writing as allowed by W. S. § 2-7-205(b) ; an order ought to be entered at this time approving, ratifying and confirming the *Final Report, Accounting and Petition for Distribution*, and all actions of the Personal Representative and the attorneys in this matter; and a Decree ought

to be entered providing for the full and final distribution of the estate and the closing thereof.

**IT IS, THEREFORE, HEREBY ORDERED** that the *Final Report, Accounting and Petition for Distribution* of the administration of the Estate of Willis Eaton Pelissier III, deceased, be, and hereby is ratified, approved and confirmed by the Court; and that the Personal Representative and attorneys for the estate have, fully and properly administered and handled the estate in Wyoming in accordance with law, and in accordance with all duties which they owe to the estate and to the beneficiaries of the estate.

**IT IS FURTHER ORDERED** that the attorneys for the estate, the firm of Davis & Cannon, LLP of Sheridan, Wyoming, have rendered all services required in an estate of this kind and size, and hereby are allowed statutory attorney's fees for ordinary services in the amount of Four Thousand Six Hundred Fifty-Two Dollars and No Cents (\$4,652.00), together with out-of-pocket expenses paid by the attorneys for publication and other costs in connection with the administration of the estate, said costs now being Five Hundred Sixty-Five Dollars and Thirty-Five Cents (\$565.35), plus any accruing costs. The attorneys for the estate shall further be entitled to any additional out-of-pocket expenses for costs advanced in winding up and closing the estate.

**IT IS FURTHER ORDERED** that the Personal Representative has waived the statutory fee for the administration of the estate provided by W.S § 2-7-803.

**IT IS FURTHER ORDERED** that the following described personal property be and hereby is distributed unto Kelley C. Pelissier, to-wit:

Real property located at 947 Exeter Avenue Sheridan, Sheridan County, Wyoming, described as follows:



**IT IS FURTHER ORDERED** by the Court that pursuant to the Will of the decedent, all other real or personal property, whether herein described or not, and whether or not now known to exist or hereafter discovered, be and the same hereby is distributed to Kelley C. Pelissier.

**IT IS FURTHER ORDERED** that after distribution of the property and after payment of the costs of administration, there is no other property in the estate. No further proceedings in the administration of the estate shall be required.

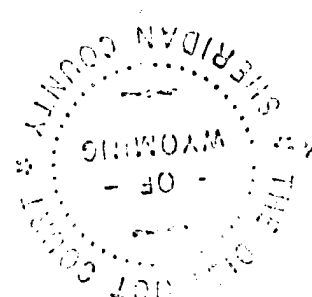
The Personal Representative shall execute and deliver such legal instruments as shall be necessary or appropriate to effectuate distribution of the estate.
