RATIFICATION AND RESTATEMENT OF RIGHT OF FIRST REFUSAL

This Ratification and Restatement of Right of First Refusal is entered into by and between FRANCESCO G. BEUF, TRUSTEE OF THE FRANCESCO G. BEUF REVOCABLE TRUST DATED January 25, 1995, as amended and restated, (herein referred to as "Grantor"), whose address is 1062 Utica Circle, Boulder, Colorado 80304 and SUMMERFIELD K. JOHNSTON, JR., a married person dealing in his sole and separate property, whose address is 100 West MLK Blvd., 600 Krystal Building, Chattanooga, Tennessee 37402 (herein referred to as "Grantee").

WHEREAS, Carlo Beuf and Beatrice Gallatin Beuf entered into that certain *Agreement* with Burns Ranches, Inc. which was recorded on October 7, 1980 at Book 252, Page 113 in the office of the clerk of Sheridan County, Wyoming (the "Agreement").

WHEREAS, in the Agreement, Carlo Beuf and Beatrice Gallatin Beuf granted a right of first refusal to Burns Ranches, Inc., which was a covenant running with the land, binding upon and inuring to the benefit of the parties' successors in interest.

WHEREAS, the right of first refusal burdens the following lands then owned by Carlo Beuf and Beatrice Gallatin Beuf:

- 2. The parties each represent to the best of their knowledge to the other that the right of first refusal is in good standing and that there are no facts which support any claim that either parties' rights under the right of first refusal have been waived, terminated, or lapsed for any reason.
- 3. All references in the Agreement to the "First Parties" shall hereinafter be considered to be references to FRANCESCO G. BEUF, TRUSTEE OF THE FRANCESCO G. BEUF REVOCABLE TRUST DATED January 25, 1995, as amended and restated.
- 4. All references in the Agreement to the "Second Parties" shall hereinafter be considered to be references to SUMMERFIELD K. JOHNSTON, JR.
