## RIGHT OF WAY AGREEMENT

THIS AGREEMENT, Made and entered into this 30 day of November, 1935, by and between Eurie Leach, a widow, of the County of Sheridan, State of Wyoming, party of the first part, and the City of Sheridan, a municipal corporation of Sheridan County, State of Wyoming, party of the second part, WITNESSETH:

THAT For and in consideration of the sum of One Dollar (\$1.00) and other valuable consideration to the party of the first part in hand paid by the party of the second part, the receipt whereof is hereby acknowledged, the party of the first part does hereby grant to the party of the second part, its successors and assigns, a right of way as hereinafter described to construct, maintain, remain, replace and operate a water pipe or water pipes and flow line, with necessary valves, vaults, manholes, ventilators, service and auxiliary pipes and appurtenances in, through and across the following described tracts of land situate, lying and being in the County of Sheridan, State of Wyoming, to-wit:

A tract of land in the West half of the Southeast quarter (W#SE#) and the Northeast quarter of the Southeast quarter (NEISEE) of Section 9, Township 55 North, Range 55 West of the Sixth Principal Meridian, more particularly desoribed as follows: A strip of land 20 feet wide and 3047 feet long whose center line is as follows or as the pipe will be laid on the curves; Beginning at a point South 84 degrees 30 minutes West, 359 feet more or less from the East quarter corner of said Section 9, said point being on the north boundary line of the property and is the intersection with the State Highway Right of Way; thence South 63 degrees 58 minutes West 57.4 feet more or less to a point; thence South 75 degrees 59 minutes West, 224.2 feet more or less to a point; thence South 75 degrees 58 minutes West 214.3 feet more or less to a point; thence South 76 degrees 27 minutes West, 560.1 feet more or less to a point; thence South 42 degrees 02 minutes West, 524.7 feet more or less to a point; thence South 36 degrees 47 minutes West, 1466.3 feet more or less to a point, said point being on the West boundary line of the property and is the intersection with the County road right of way.
