



Bearing and distances are approximated based on GPS data gathered and projected into NAD 83 Wyoming State Plane, East Central Zone, US Survey feet.



An easement 30 Feet in width, being 15 Feet on each side when measured at right angles to the following described line. Commencing at the Southeast Corner of Section 24, T57N, R84W located at 44°53'38.088"N, 106°55'33.508"W, thence N0°22'10"W a distance of 35 Feet, more or less, to the Point of Beginning; thence S89°36'31"W a distance of 42 Feet, more or less; thence N32°11'52"W a distance of 1612 Feet, more or less; thence N18°19'20"W a distance of 306 Feet, more or less, thus to the ending point.

The above described is for power line ROW extending a total of 1960 Feet, more or less.
