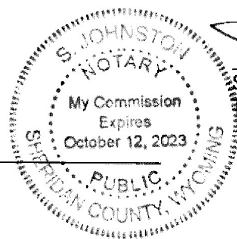

EXHIBIT "A"
LEGAL DESCRIPTION

A tract of land in the NE1/4 of Section 36, Township 56 North, Range 85 West, 6th Principal Meridian, Sheridan County, Wyoming, commonly known as Tract 7 of the Bozeman Trail Ranches, an unrecorded subdivision, said tract being more particularly described as follows:

Commencing at the northeast corner of said Section 36 (monumented with a 6" brass cap per U.S. Military Reservation Survey); thence S89°17'15"W, 770.26 feet along the north line of said Section 36 to a 2" aluminum cap per PLS 2615, said point being the POINT OF BEGINNING of said tract; thence S04°40'08"W, 1,549.45 feet to a 2" aluminum cap per PLS 2615 lying on the northerly right of way line of a sixty foot wide roadway; thence N73°03'42"W, 280.65 feet along said right of way line to a 2" aluminum cap per PLS 2615; thence, along said right of way line through a curve to the left, having a radius of 602.96 feet, a delta of 10°18'48", an arc length of 108.53 feet, a chord bearing of N78°13'06"W, and a chord length of 108.39 feet to a 2" aluminum cap per PLS 2615; thence N83°22'29"W, 309.41 feet along said right of way line to a 2" aluminum cap per PLS 2615; thence, along said right of way line through a curve to the right, having a radius of 351.97 feet, a delta of 43°21'10", an arc length of 266.32 feet, a chord bearing of N61°41'54"W, and a chord length of 260.01 feet to a 2" aluminum cap per PLS 2615; thence N40°01'19"W, 326.40 feet along said right of way line to a 2" aluminum cap per PLS 2615; thence N06°05'03"E, 1,023.09 feet to a 2" aluminum cap per PLS 2615 lying on said north line of Section 36; thence N89°17'15"E, 1,138.52 feet along said north line to the POINT OF BEGINNING.
