CERTIFICATE OF PARTIAL VACATION OF PLAT

WHEREAS, SSR Construction, Inc., a Wyoming corporation, (herein the "Owner"), is the sole record owner of the following described real property described as ALL of Cottonwood Point Subdivision EXCEPT Lot 22, City of Sheridan, Sheridan County, Wyoming, Recorded April 23, 2009 in Drawer C, Plat #73 by SBC Development LLC. hereto (the "Property");

Owner, by these presents, does make the above partial vacation for it and for its successors and assigns, and for all future owners of said Property, as the same shall be re-platted as COTTONWOOD SUBDIVISION.
