cipal Meridian, Sheridan County, State of Wyoming,

Beginning at a point, which point is South 3°55'
West 1329 feet from the center of said Section 34;
thence North 89°57' West 1203 feet; thence South 0°16'
East 633.8 feet; thence North 89°54' East 173.2 feet;
thence South 2°20' East 6.5 feet; thence North 87°27'
East 1030 feet; thence North 0°17' West 593.3 feet to
the point of beginning.

as appears on said plat is filed with the free consent, and in
accordance with the desires of the undersigned owners and pro-
prietors who hereby dedicate the said plat to the same effect as
if they had signed and executed a certificate of dedication at
the time the said plat was filed.

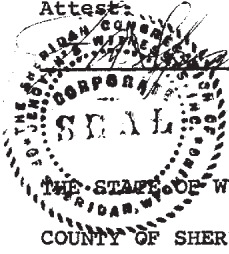
