

NOTICE OF WATER SERVICE PERMIT

The Sheridan Area Water Supply Joint Powers Board hereby gives notice that Water Service Permit Number 155 has been approved and issued to: FRANCIS M. LEGRSKI, 361 BIG GOOSE ROAD, SHERIDAN, WYOMING 82801. Said permit pertains to a parcel of real property situate in Sheridan County, Wyoming, to-wit:

A tract of land, containing 29.78 acres, more or less, situated in the West half of the Southeast quarter and the East half of the Southwest quarter of Section 31, Township 56 North, Range 84 West of the Sixth Principal Meridian, described as follows:

Beginning at a point which is South 66°30' East 430 feet from the Northwest corner of the Southeast quarter of the Southwest quarter of said Section 31; thence North 62°37' East 1160 feet to a point; thence South 30°54' East 1318 feet to a point; thence South 72°06' West 440 feet; thence South 80°41' West 144 feet; thence South 87°03' West 110 feet; thence North 82°22' West 314 feet; thence North 68°00' West 584 feet; thence North 41°32' West 50 feet; thence North 24°37' East 191.5 feet; thence North 40°30' West 356 feet to the point of beginning; excepting the following described tract of land: Beginning at a point S.70°30' E., 1470 feet from the Northwest corner of the SE1/4SW1/4 of said Section 31; thence N. 59°54' E., 169.3 feet; thence S.50°05' E., 397.6 feet; thence S.43°28' E., 160.8 feet; thence S. 76°53' W., 269.5 feet; thence N. 46°48' W., 331.1 feet; thence N. 25°47' W., 134.6 feet to the point of beginning.
