## WILLISTON BASIN INTERSTATE PIPELINE COMPANY PIPELINE EASEMENT BY OWNER

DAILEY, COUNTY CLERK THIS INDENTURE, made this CIA day of octobal A.D., 19 25, between WILLISTON BASIN INTERSTATE PIPELINE COMPANY, a corporation. Suite 300, 200 North Third Street, Bismarck, North Dakota 58501, hereinafter called "COMPANY" its successors and assigns, and the following named persons, herein, whether singular or plural, called "OWNER," namely:

FLORENCE J. OLSON, A SINGLE WOMAN 3840 EAST 18th #1104 CASPER, WYOMING, 82609

WITNESSETH, that for valuable considerations received, OWNER does hereby grant, bargain, sell and convey unto COMPANY, its successors and assigns, an easement 50 feet in width, being 25 feet left, and 25 feet right of the center line as laid out and/or surveyed, or as finally installed on the hereinafter described lands, together with the right to construct, operate, maintain, repair, increases the capacity of, remove, and replace a gas pipeline or lines, including necessary pipes, poles, and fixtures, through, over, under and across the following described real estate, situated in the County of Sheridan State of Wyoming namely:

A tract or strip of land lying in the Northeast Quarter of the Northeast Quarter (NEANEA) of Section Twentynine (29), Township Fiftyfour (54) North, Range Eightythree (83) West of the 6th Principal Meridian, said strip being Fifty (50) feet wide, Twentyfive (25) feet on each side of the following described centerline:

Beginning at a point which is South 0°03' East, 27.2 feet from the Northeast Corner of said Section 29, thence North 27°00' West a distance of 30.4 feet to a point on the North line of Section 29 which is South 89°23' West, 14.7 feet from the Northeast Corner of Section 29.

Should additional pipelines be laid under this grant, at any time, an additional consideration equal to the consideration paid for this grant, calculated on a lineal rod basis, shall be paid for each additional line.

OWNER, its successors and assigns, agrees not to build, create or construct or permit to be built, created, or constructed, any obstruction, building, engineering works or other structures upon, over, or under the strip of land herein described or that would interfere with said pipeline or lines or COMPANY'S rights hereunder.

OWNER, its successors and assigns, hereby grants to COMPANY, its successors and assigns, the right at all reasonable times to enter upon said premises for the purpose of laying, constructing, maintaining, operating, replacing, increasing the capacity of, repairing or removing said gas pipeline or lines and for the purpose of doing all necessary work in connection therewith.

COMPANY hereby agrees that it will pay any and all damages that may result to the crops, fences, buildings and improvements on said premises caused by constructing, maintaining, repairing, replacing, increasing the capacity of, operating or removing said pipeline or lines. The damages, if not mutually agreed upon, may be determined by three disinterested persons, one to be selected by COMPANY and one by OWNER; these two shall select the third person. The award of these three persons shall be final and conclusive.

If the herein described lands are in the State of North Dakota, this easement is limited to a term of 99 years.
