AMENDED EXHIBIT "A"

In further consideration hereof, Grantee further agrees that during the next ensuing planting season, but in no event later than one year from the date hereof, Grantee shall re-seed with appropriate good quality seed all of the above described lands as have been heretofore disturbed by Grantee in the exercise of the rights granted to Grantee; the entire cost and expense of such planting shall be borne solely by Grantee.

Grantors to have the right to fully use and enjoy the above described premises, except to the rights herein granted, and Grantors agree not to build, create or construct, nor permit to be built, created or constructed, any obstruction, building, engineering works, or other structure over said pipeline or lines. Grantee hereby agrees to pay any damages which may arise to growing crops, pasturage, fences or buildings of said Grantors from the exercise of the rights herein granted, said damages, if not mutually agreed upon, to be ascertained and determined by three disinterested persons, one thereof to be appointed by Grantors, one by Grantee, and the third by the two so appointed, and the written award of such three persons shall be final and conclusive.
